## **HOW DO YOU MAKE MONEY AS AN INVESTOR? - Continues:**

Whenever each card is sold for \$99. We (the company) would keep **\$29**. You (the royalty investor) would keep **\$20** and The Distributor (Sales Agent) would keep **\$50**

For example, if we sell only 1,000 ads (1,000 gift cards) in one particular month, we'll pay our royalty investor ( $\$20 \times 1,000$ ) = \$20,000 for that month.
